

Citation Ordinance Amendment

Amendment No. 3

Amending Town of Frankfort Ordinance No. 2006-1, entitled, Citation Ordinance and the Town of Frankfort Code of Ordinances Section 4.3, Section 7.3, Section 10.1 and Section 12.0.

The town board of the Town of Frankfort pursuant to its authority under Section 66.0113 Wis. stats. and has the general authority under its Village powers under 60.22 Wis stats. does hereby amend the Town of Frankfort, Citation Ordinance and does ordain as follows:

1. Section II - Authority is hereby repealed and recreated as follows:

Section II - Authority "The town board of the Town of Frankfort, Pepin County, Wisconsin has the specific authority under s. 66.0113 Wis. Stats., to adopt this ordinance."

2. Section IV - Coverage (B) is hereby repealed and recreated as follows:

Section IV – Coverage (B) "The town board adopts the following schedule of cash deposits that are required for the various Town of Frankfort ordinance violations per offense. Additional to each listed violation would be the current associated costs, fees, and surcharges imposed under ch. 814, Wis stats; plus the costs of prosecution:

1. Ordinance No. 2005-2, Building Permits - \$25.00.
(Reference Section IX – Penalties)(Town of Frankfort Code of Ordinances Section 10.1)
2. Ordinance No. 2005-3, Highway Access - \$25.00.
(Reference Section XI – Penalty Provision)(Town of Frankfort Code of Ordinances Section 4.3)
3. Ordinance No. 2012-1, Nonmetallic Mine Operator's License Ordinance – \$1000.00 - \$5000.00. (Reference Section 9(5)(a) – Penalties)(Town of Frankfort Code of Ordinances Section 7.3)
4. Ordinance No. 2012-4, Ordinance for Adoption of Wisconsin Uniform Dwelling Code - \$25.00 - \$500.00. (Reference Section 10.207 – Penalties)
5. Ordinance No. 2013-3, Town of Frankfort Zoning Ordinance - \$50.00 - \$1000.00. (Reference Section 17.02(4) - Penalties)(Town of Frankfort Code of Ordinances Section 12.0)
